## 018/20 Planning - Trees in Churchyard

Planning application ref: 20/00534/TCA has been refused and H.D.C. have placed an initial Tree Preservation Order on the Trees for an initial temporary period of 6 months.

(Cllr TR) Proposes that Stoughton Parish Council write to HDC re: temporary TPO on Church Trees, acknowledging their action, but urging them to make a quick and equitable decision as the scheme is one of Health and Safety and is becoming an ongoing nightmare for Church Warden and DCC.

Cllr (TR) cannot see how the Parish Council can object to someone repairing and making safe his own property. The intentions of the owner are currently unknown.

He stated that the owner may also need to consider security if the building was to be used for storage purposes in such a quiet rural location. The parish Council cannot object to the owner repairing and making safe of the building.

# 19/01921/FUL Paddock adjacent to White House, Gaulby Lane, Stoughton

Cllr (TR) felt that Stoughton Parish Council should object in the strongest possible terms to the above proposal on the following grounds that the site is registered as Local Green Space (LGS/STO/1) and this was ratified by Harborough Local Plan (2011 – 2031) only one year ago. He also stated that he believes the land is within the Thurnby/ Leicester/Oadby Green Wedge (as is all land outside the existing building footprint of Stoughton.)

A recent test case (APP/F2415/W/15/3014897) ruled that, without any public transport/outlets/facilities, no more building in Stoughton is sustainable. Cllr (TR) also commented that the position of the site is described as 'close to public transport routes' when this is not so, as any connection with public transport involves a drive to Oadby, Evington or Thurnby.

#### 024/20 Permissive Footpaths

Stoughton Parish Council have received an enquiry from a Parishioner about the future of the Permissive Footpath scheme on the Stoughton Estate when the EU funding expires this year.

Cllr (TR) stated that for his part he has have greatly appreciated the Permissive Footpath system which came about nearly 10 years ago. He believes they have been respectfully used and have never seen any sign of abuse or littering. They have been a blessing recently in this COVID time, allowing parishioners to walk and take exercise in splendid isolation and beautiful surroundings.

Cllr (JS) has circulated maps of permissive footpaths.

Following the enquiry Clerk (KG) has contacted LRALC for advice.

LRALC have responded saying there is no legal topic note which covers this area. Cllr (PC) said the Parish Council should take up the Parishioners points as a lot of people use the permissive footpath by the lake and would also like to include the Lady Walk. He suggested that the Parish Council should obtain some advice as there are anomalies at present particularly with the entrance from Stoughton Lane and the Lady Walk.

Cllr (TR) suggested that a letter of thanks be sent to the Parishioner for bringing this matter to the attention of the Parish Council.
